President's Newsletter Article February 2023

Greetings from your President. I hope this newsletter article finds that all is well with each and every one of you. Bonnie and I are busy doing lots of things in our lives including FCE, ACWW, and of course, Keeper's Corner. I am substituting teaching almost every day and still enjoying it. This is my 50th year of teaching. I am also working a lot in my home shop building lots of various wood projects. You can check them out on the Keeper's Corner Facebook page.

I have had some great things happen in my life and some very tough things. On April 1, 2023, I set some very strong goals including losing lots of weight and getting the A1C reading way down for my diabetes. I was doing great on those two things and the doctor was very happy with my weight loss and A1C control but was very concerned about my PSA (Prostate Cancer testing) readings. So, then the bad news. After further testing it was determined that my Prostate Cancer has returned. It has been a battle, but we are winning it. I have been put on hormone treatment and my PSA numbers are now outstanding. Thanks to great doctors, great medication and the blessing of my Lord and Savior Jesus Christ.

I went to the doctor on Wednesday January 24, and he was excited about my blood work, my test results, and my blood pressure. My A1C is 5.2 (non-diabetic range), my blood pressure was 103/60 (it was so low I asked him if I was still alive), my PSA is .01 (which is a perfect reading), and I have officially lost 99 ½ pounds. I have surely been

blessed through lots of work and prayers from everyone.

If you haven't been on the Oregon FCE website, or the National FCE websites lately, now's the time to do so. I have spent hours scanning and posting "Lessons from the Past" on the Oregon FCE website. There are a total of 158 lessons available for you to view, print, or download. The National FCE website "Members Page" has hundreds of lessons available. You will need a password to get on it and I can give it to you.

Your Oregon FCE State Board approved, and has started the Oregon FCE High School Age CHARTACTERCOUNTS!© Essay Contest. Lots of work has been done about getting the information out to high school age students. We don't have a count of how many are participating because the deadline is March 1, 2024, for the contest entries. FCE is well and alive. I'm hearing of various FCE and volunteer activities from all across the state of Oregon and across the nation. Lots of lessons being given and lots of learning going on. We may be few in numbers, but we are all strong in spirit and dedication to FCE. Keep up the great work.

We did have a major loss of members in Clackamas County (District 1). Clackamas County has disbanded, and we have lost up to 38 Oregon FCE members. There are several reasons they disbanded including "aging out" but I really think a major contributor to the reason was because of "burn-out" of leaders. No one was willing to step up and take over the offices that so many had served faithfully for, sometimes for many years. I sent out a letter to all 38 of those past members inviting them to become "Independent" members and, as of this writing, have received three "Independent" memberships. If you know any of these people, please invite them to join as an "Independent" member.

We were again able to hold an "in person" 2023 Oregon FCE State Conference this year and all of those attending had a great time visiting, socializing, and getting to see everyone. The Conference was held at the Hilton Garden Inn in Springfield. The State Board, the Conference Committee, and lots of volunteers took on assignments and did a wonderful job planning and hosting the Conference. It took a "Village" to put it on, but everything went well. A big thank you to all those that helped. The number of attendees was up from last year with 31 full time attendees. The excitement was up, and all of the Conference evaluations rated it number ONE. Everyone loved the hotel, the hotel workers, the hotel location, and the wonderful food they served. We had great speakers, great classes, wonderful tours of the area, great activities, and games, but most of all we had great friends. We didn't have a "Sales Room" this year, we had a "Country Store" and sold raffle tickets for all of the items. The "Country Store" was a big hit and we're doing it again this year. Everyone met at least one new friend. Some non FCE friends were invited to attend. At least 2 new members joined FCE because of that loving, sharing, and inviting. If you weren't there, we missed you, and hopefully we'll see you at the Conference this year.

The 2024 Conference is going to be held again at the same location. The contract with the hotel is ready to be signed and we are ready to go. The dates of the 2024 Conference will be September 30 through October 2, 2024. A little earlier than usual. The theme of the Conference is being decided soon. Your input is needed on that selection. Your FCE State Board has taken over the task of hosting the Conference. They, along with FCE members, Study Groups, Counties, and Districts will take over that task. It worked very well in 2023. They will use help from all around the state of Oregon. There are lots of assignments and tasks that need to be done and most of them have had volunteers step up for them. We are currently working on the lessons for the Conference. If you have suggestions, please let me know.

As things go, we hope, are changing for the better, let's make sure that we are getting back at doing all of our normal activities including volunteering, meeting in our Study Groups, County Council meetings, District meetings, and also our State

Conference. Be sure to schedule and hold those special events that we have had in the past. Please Invite me to your various activities and I'll do all I can to be there.

The Oregon FCE Zoom lessons will continue onward this year. February 7, 2024 will be our 38th monthly lesson. They are usually held on the first Wednesday of the month. FCE members, and friends of FCE have participated from all across the USA. There have been "Guest Presenters" from Oregon, Virginia, West Virginia, Hawaii, Kansas, Florida, Maryland, Tennessee, Nebraska, North Dakota, and Mississippi. All of the Zoom Lessons have been recorded and are available on the Oregon website www.oregon-fce.org. Please let me know if you'd be interested in being a presenter.

The 2024 National FCE Conference is going to be held in Erlanger, Kentucky on July 25-28, 2024. The National FCE Alumni Association sponsors some National Conference Scholarships (which pay full registration cost). Oregon FCE also has some National FCE Conference Scholarships available. Before I close this President's report, I want to, as I always do, repeat "Scott's Challenge." My challenge to you is to do all that you can do to "Grow" this organization. This is an extremely difficult thing to do in these tough times, but together we can do it. We, as FCE members, can make a difference in increasing our membership. Every one of you was "Invited" to join this organization. Now it's your turn. Don't do this great organization a disservice by not inviting others to join. Don't let FCE die. You, each of you, can be the salvation of Oregon FCE. One last reminder, if we don't do something to help this organization grow, the challenges of "Aging Out", "Burn Out", and an "I don't care attitude" will destroy this organization. Become part of the solution. Don't be a "Nay-Sayer," become a "Yay-Sayer."

If we, all of us, don't start doing these things, we will continue to see the slow, if not quick, decline in FCE membership. If you don't care, do nothing and nothing will happen. Do your part and we can stop, and even increase the FCE membership. It all starts with you and me. Let's all make FCE all that it can

be. We need to start today! How many of you are willing to accept the challenge I give you today and always?

It has been a great honor to serve each of you and I hope you know that I have done it to the best of my abilities. I appreciate all the love and support that each of you have given me, from the individual FCE members up to the many FCE officers. Working together, we can accomplish many great things at all levels of FCE. If I have somehow offended you, it was not intentional, and I apologize to you.

I am excited about the things that we have done, can do, and will do in Oregon FCE. With all of us working together we can make Oregon FCE all that it can be. "It is what you will it to be".

Comments from 2023 State Conference Ann Conklin

These are some of my thoughts on why the 2023 state conference went so well. Everyone pitched in to make it happen, from the leadership from the board, from the great helpers at the Hilton and the great help from the study groups from all over the state. It ran very smoothly and we all enjoyed, good lessons, good food and good craft making.

Treasurers report

As the Oregon FCE Treasurer, I am not only concerned about the financial bottom line, I am also very concerned about our membership numbers.

I want to congratulate the groups that have invited and recruited new members for 2023 and 2024! YOU are helping FCE grow and thrive!

I've been doing some research about member retention and engagement. I have found that for nonprofits and associations, member recruitment is about more than revenue. Losing members is hard on any organization. Members are the lifeblood of our organization. They make the magic happen! Members are more than money in the coffers, members are the ideas, the excitement, the leadership encouragers, the upcoming leaders. They are the fuel that keeps our organization going!

Some research I read stated that with ideal member retention sitting at 80% year over year, some membership loss is inevitable. That's why membership recruitment is so important—yet 68% of organizations face challenges in membership growth. That's more than two-thirds! I count Oregon FCE in that 68%!

Before you start recruiting, ask yourself: What does the recruitment journey for new members for FCE look like now, and what should it look like going forward? In other words: WHY would anyone want to join FCE? WHAT do we have to offer members? HOW will we retain new members once they join? Here are a few steps to think about when you are trying to get new members.

Step 1: Capture. Prospective members are "captured" when they're looped into our organization's workings, be it by email, a newsletter, attending an event, or word of mouth.

Step 2: Nurture. After they attend, send followup emails, or phone calls nudging prospective new members along the path to signing up. Make prospective members feel appreciated and valued with personalized attention, especially if they've shown interest in the organization! (Then after they are members continue to make them, as well as current members, feel valued!)

Step 3: Conversion. Offer incentives to signing up, like membership benefits. You might also emphasize key aspects of the membership experience, like networking or community impact we have with our lessons and service projects. Providing a smooth and personalized member experience is one of the most important tools we have—even at the recruitment stage. You want to make sure prospective new members are given every incentive to make it all the way through to the sign-up process and that they feel welcomed and comfortable in the group.





Pear and Cranberry Crisp

1/2 cup old fashioned rolled oats

1 Tablespoon brown sugar

2 Tablespoons flour

1/4 teaspoon cinnamon

2 Tablespoons applesauce

4 cups pears, cubed (about 3 pears)

1 cup cranberries, fresh or frozen

1 Tablespoon cornstarch

In a medium bowl, combine oats, brown sugar, flour, cinnamon and applesauce.

Combine pears, cranberries and cornstarch in an 8x8 inch baking dish. Sprinkle with oat mixture. Bake uncovered at 400 degrees until juices are bubbling and topping is browned, about 20 minutes. Makes 4 cups. Refrigerate leftovers within 2 hours. Find other recipes on FoodHero.org
