I hope that each of you are getting ready for and planning on going to the 2023 Oregon FCE Fall Conference. I have updated the "Friends of FCE Conference Scholarship" application and it also will be included in this newsletter. The theme of the Conference is "FCE, Building Blocks for Today and Tomorrow." The six classes for the Conference include: 1. Ovarian Cancer, the Silent Killer; 2. Easy Ways to Go Green; 3. Cascadia Subduction Zone; 4. Savory Meals for 1 or 2, Ways to a Joyous Life; 5. Human Trafficking, It's Not Just Sex Trafficking; 6. Filling Your Pantry

on a Budget. We are also having a session for some Crafting Activities and Games.

The dates of the 2023 Conference are October 1-4, 2023, and will be at the same place as the last two years in Springfield, Oregon. We will have 6 wonderful new lessons, a wonderful guest speaker, a couple of great presentations, and lots of fun and fellowshipping. We will again be doing our FCE Country Raffle, the Margaret Seibold Auction, and the Door Prize Basket drawing. We will need donations for each of those. More information is located in other parts of this Newsletter.

Last year, an Assignment/Volunteer List, for the Conference, was used, and it worked great. It was wonderful to have all of those helping hands, and minds, from so many from across the state. If you ever have any suggestions, comments or concerns that we, as a Board, need to know, please let us know and we'll discuss it in our meetings.

"Person to Person...Searching for the Silent Killer-Ovarian Cancer"

"Human Trafficking..." It's Not Only About Sex Trafficking!

"Cascadia Subduction Zone"

Am I prepared for the BIG ONE?

What is the Cascadia Subduction Zone and why is it important to ME? The Cascadia Subduction Zone is a 600-mile fault that runs from northern California to British Columbia and is about 70-100 miles off the Pacific coast shoreline. There have been 41 earthquakes in the last 10,000 years within this fault that have occurred as few as 190 years or as much as 1200 years apart. According to some we are overdue! Learn where the worst might happen and what we can do to be better prepared.

Taught by Bonnie Teeples and Barbara Lougnot Bonnie has been a member of FCE since 1979. She joined the organization because a friend asked her to go to a meeting. She loved it and joined! Her group was primarily made up of young homemakers like herself. They had 35 members and about 25 littles in their paid nursery! One of the earlier meetings she attended was a class on deboning a whole chicken. It was fun the first time, and she did it for her family one more time. It was too time consuming to do it for a large family!

She has served in various study group and county council offices. She served on the State Board in two positions before being elected as Oregon FCE State President. After her term as State President, she was elected to the National FCE Board and served in various positions before being elected as the National FCE President.

She is currently serving as Oregon FCE Treasurer and as the ACWW USA Area President.

Some of her greatest memories of FCE are the memories she has had with her FCE FAMILY. She loves this organization and wants so much for others to have the experiences she has had as she serves.

Creative Homemakers FCE study group Turns 50!

The early years

With the encouragement of our Extension Agent, Monine Strode, we started in 1973 with seven members and named ourselves The Yamhill County Young Homemakers. By the end of 1975 our group had grown – even had 6 babies. We needed to raise money to pay for babysitters. We had garage sales, rummage sales, (made \$40) sold cards and stationary (made \$40), had a bake goods & crafts sale at US Bank, had a booth at holiday craft sales, served pie and ice cream at Yamhill County Bank promotion (\$75) and once toured Macy's Funeral Home, our group was paid a dollar for each of us. In 1978 the group catered a dinner for 58 representatives and board members of Cascade Steel. Made \$300.

As our kids grew we didn't need babysitters, but still raised money so that we could give some away to help 4-H kids, FCE needs and have a chance to go places without kids.

Each summer we chose a tour, Bob's Red Mill, a doll factory, Pendleton Woolen Mills and shopping at John's Landing, walk Old Town Portland to visit Daisy Kingdom where a guy staggered off the sidewalk saying "Who let the cows out!" (we were in our 30's and 40's). We visited farm-stand/bakery near Woodburn, and a large lavender farm south of Amity.

In 1976 our group preformed a split stage play, a satirical comparison of a mother in 1876 and a mom in 1976. This was given for Spring Festival and at our County Fair. We gathered props, outfits and members were narrators and silent actors. We have that skit.

After other FCE groups snickered at our name, we changed it to Creative Homemakers and began to win all the prizes for best table decorations.

This May our group celebrated our 50th with colorful funny party hats with matching colorful cake made by one of our granddaughters. We played a game answering questions about stories, lessons, and activities our group has enjoyed these 50 years.

Only 2 active members have been here all 50 years, Dottye Keister and Anne Engen.

Remembering FCE Member Ardyce Snyder National FCE President 2019 to 2022

Ardyce lived in North Dakota, she wore many hats. She sold Home Interiors, helping beautify other people's homes and her own. She had been an office secretary, a licensed Real Estate Agent and started her own non-profit organization called the Golden Age Club in New Rockford, ND to assist with taxes and organization paperwork.

Ardyce loved her work with FCE. In 2019 she was awarded a "Superior Certificate" for 25 years of service. Throughout her time with FCE, she served on local, state and national boards, and from 2019-2022 she served as National President. Her work with FCE provided her with much opportunity to travel and to meet influential people far and wide.

Closely related to her work with FCE was her work with ACWW. ACWW is an international network of 450 rural women's organizations that spans 80 countries. Their work funds women-led projects around the world in the areas of health, education, and agriculture. At the time of her death, Ardyce was serving as a National ACWW Coordinator for FCE and had plans to attend their world conference in Malaysia.

Ardyce will be missed by family and many friends she knew around the country and world. Her smile lit up our lives and her infectious laugh had us all laughing along and her servant's heart is an example to us all.

STANDING RULES FOR MARGARET SEIBOLD OREGON FCE STATE CONFERENCE SCHOLARSHIP

PURPOSE: The scholarship shall provide a partial payment of the cost attending the Annual Oregon FCE State Conference. The recipient may apply this to any expenses such as registration, travel, meals and motel costs.

AMOUNT: The amount and number of scholarships to be given will be determined by the Oregon FCE Board of Directors on a year to year basis.

ELIGIBILITY: The applicant must be a dues paying member of Oregon and National FCE. A person may receive the State Conference Scholarship as well as County and or local scholarships. An applicant may not receive the scholarship more than once in a five year period. The award is not transferable

APPLICATION: The applicant will write a paragraph stating why she/he wants to be considered for the scholarship, what he/she hopes to gain from the conference and where, with whom and how the information will be shared with others.

HOW AWARDED: The Margaret Seibold FCE Conference scholarship Committee will review the applicants and select the recipient(s). Questions may be addressed to the state Treasurer. The award will be in the form of a certificate and check given during the Conference.

WHEN DUE: Applications must postmarked or emailed no later than August 30 Scholarship recipients will be notified no later than September 15.

ADMINISTRATOR: The Oregon FCE State Treasurer will be responsible for maintaining a separate interest bearing account and distribution of funds.

POLICY CHANGE: Rules governing this scholarship may be made by a vote of two-thirds of the Oregon FCE Board of Directors

You will be required to fill out an evaluation sheet, which will be given to you with the check after the conference and submit it to the treasure.

You must be registered for the complete conference to receive this scholarship.
