Conference Scholarships will be available and starting this year, we are having an Oregon FCE Member Essay Contest where people can win award money to be used towards attending the State Conference. The Board meeting will be held on Sunday afternoon so the Board members can attend the activities on Monday morning. We are also doing something new in doing two service projects on Monday morning including making "Comfort Bears" and "Lap Blankets." These are proposals and may change some.

We have been promoting the 2026 Oregon/National FCE High School Age Essay Contest. This year's theme is "RESPECT." The deadline is March 1, 2026, so time is growing short. Starting last year, it is a State and National contest. Lots of work has been done about getting the information out to high school age students. Students can win up to \$1,000.00. Last year we had 9 contestants from around the State of Oregon. This year we are predicting about 20 or more. Last year, all the essays were outstanding, and it was difficult to judge them 1st through 9th place. FCE is well and alive. I'm hearing of various FCE and volunteer activities from across the state of Oregon and across the nation. Lots of lessons are being given and lots of volunteering and learning is going on. We may be few in numbers, but we are all strong in spirit and dedication to FCE. Keep up the

I have spent hours scanning and posting "Lessons from the Past" on the Oregon FCE website. There is a total of 169 lessons available for you to view, print, or download. The National FCE website "Members Page" has hundreds of lessons available. You will need a password to get on the page, and I can give it to you.

To help with the cost of the State Conference, we are looking for Conference Sponsors including individuals, Study Groups, Counties, and businesses. Please let me know if you have any suggestions for sponsors. I have and will email out a letter and form to each of you. Please find someone to help us by doing a Sponsorship. Last year Conference Registration amounts brought in a lot less money than our expenses. Thankfully the Sponsorship donations canceled out the loss in revenue. We are NOT going to raise the conference registration amount, so we really need your help in finding and recruiting Conference sponsorships.

Let's make sure that we are doing all our normal activities including volunteering, meeting in our Study Groups, County Council meetings, District meetings, and our State Conference. Be sure to schedule and hold those special events that we have had in the past. Please Invite me to your various activities and I'll do all I can to be there.

The Oregon FCE Zoom lessons will continue onward this year. Wednesday, February 4, 2026, was our 62nd monthly lessons. They are usually held on the first Wednesday of the month. FCE members and friends of FCE have participated from across the USA. There have been "Guest Presenters" from Oregon, Virginia, West Virginia, Hawaii, Kansas, Florida, Maryland, Tennessee, Nebraska, North Dakota, Idaho, and Mississippi. Treasurers Bottom Line-

Each board meeting, I give a financial report on the condition of the Oregon FCE Treasury. All board members including each District Director are given copies of the balance sheet, the current profit and loss report, and, at the Fall Board meeting I generally have a report called "The Bottom Line". The purpose of these reports is for your board of directors to assess the state of Oregon FCE finances. I encourage them to share this information with members of Oregon FCE. I feel it is important that YOU ALL know that the board is working hard to keep finances in check and, since we are continually losing members, to make sure that we can meet our obligations and keep our balances in the black!

As reported at the 2025 Fall conference we have an overall balance of \$69,981.89. This is an all-inclusive balance of our investments (CD's), Education Fund Savings account, and our checking account. If you would like to know the balance of each fund, please contact your District Director, or me, and we can get a copy of the reports for you.

The thing that concerns me most right now is not the money issue; it is that our membership has fallen to 89 in 2025. I do not have an accurate count for membership in 2026 as there are still a couple of counties to get their membership turned in. Oregon has not had a significant gain in membership since 2011, when there was a gain of 50 members. Since that time, we have lost anywhere from 10-60 members EACH and EVERY year. Those numbers are sobering. WE will be a defunct organization within a few years if we continue to go the way we are going.

Years ago, I was told a true story of an FCE group in the mid-west. The state members were asked by their state leaders to increase the membership of each of the study groups by one or two people. (A very attainable goal!) One group wrote to the leaders and said "We only have 12 chairs for people to sit on at the meetings. We cannot get new members until someone drops out or dies, because we wouldn't have room for them to sit." REALLY??? Soon, with that attitude, even those twelve chairs will not be needed. Unfortunately, some of the excuses I hear from members around our state are just as shocking.

What is it that keeps you from inviting someone to your meetings? Do you feel the lesson information is not important? Do you feel they wouldn't be interested? Do you feel that our organization is not what they are looking for? Don't judge their answer. Maybe they are looking for a group of any kind to join. A place where they can learn, be welcome, gain new friends, serve others, or gain a new perspective on life. Someone is yearning to be a part of an organization that makes a difference in the community, the state, the nation, and the WORLD! We have that organization!! You only need to ASK someone to JOIN your group, many times the answer will be YES! FCE has so much to offer people. Sometimes all someone needs is an opportunity to be part of a great organization. To be ASKED to join.

What are you willing to do to keep Oregon FCE alive? Are you willing to SHARE what we do and who we are? Are you willing to LOVE your organization and your friends enough to keep the organization going? Are you willing to INVITE someone to one of your meetings?
